



## **IMPORTANT INFORMATION IN RELATION TO CAPITAL GRANT FUNDING (CHILDCARE OFFER)**

**Please read carefully before starting to write your application form.**

**Capital funding is available for the following 3 categories:**

1. Minor works/adaptations to registered childcare settings
2. Resources and equipment (general) including IT equipment
3. SEN specialist resources

Please refer to the Guidance and Terms and conditions for further information on what can and can not be funded.

The maximum amount available to anyone registered childcare setting is as follows:

- **Childminders and those registered for 8 or fewer childcare places £5,000**
- **Childcare providers registered for 9 to 15 places £7,500**
- **Childcare providers registered for 16 + places £10,000**

You are able to apply for any/all of the capital funding categories, as long as you do not exceed the funding thresholds. However, if you select to only apply for funding for **resources and equipment (general)** the following maximum funding thresholds have been set:

- **Childminders up to £1,500**
- **Day nurseries up to £3,500**
- **Cylchoedd Meithrin/Playgroups £2,750**
- **After School Clubs/Holiday Clubs £2,250**

**Please do not apply for more than the above thresholds as your applications will not be considered.**

Please make it clear on your application form which of the 3 above categories your proposal falls under.

You will also need to demonstrate which of the following your proposal addresses:

- Increases the number of childcare places you are able to offer
- Improves the quality of facilities you offer
- Lowers the age range of your provision to include 3 and 4 year olds

1. mân waith/addasiadau i leoliadau gofal plant cofrestredig
2. adnoddau ac offer (Cyffredinol) gan gynnwys offer TG
3. adnoddau arbenigol AAA

Darllenwch y canllawiau a'r telerau ac amodau i gael rhagor o wybodaeth am yr hyn y gellir ac na ellir ei hariannu.

Dyma'r uchafswm sydd ar gael i unrhyw sefydliad gofal plant cofrestredig:

- **gwarchodwyr plant a rhai sydd wedi'u cofrestru ar gyfer 8 neu lai o leoedd gofal plant £5,000**
- **darparwyr gofal plant wedi'u cofrestru ar gyfer lleoedd 9 i 15 £7,500**
- **darparwyr gofal plant wedi'u cofrestru ar gyfer lleoedd 16 + £10,000**

Gallwch wneud cais am unrhyw un neu'r cyfan o'r categorïau cyllid cyfalaf, ar yr amod nad ydych yn mynd y tu hwnt i'r trothwyon ariannu. Fodd bynnag, os byddwch yn dewis gwneud cais am gyllid ar gyfer **adnoddau a chyfarpar (Cyffredinol)** yn unig, pennwyd y trothwyon ariannu uchaf canlynol:

- **gwarchodwyr plant hyd at £1,500**
- **meithrinfeydd dydd hyd at £3,500**
- **cylchoedd meithrin/cylchoedd chwarae £2,750**
- **Clybiau ar ôl ysgol/clybiau gwyliau £2,250**

### **Peidiwch â gwneud cais am fwy na'r trothwyon uchod gan na fydd eich ceisiadau yn cael eu hystyried.**

Gwnewch yn glir ar eich ffurflen gais pa un o'r 3 chategori uchod y mae'ch cynnig yn perthyn iddo.
