## CEISIADAU GRANT CYNALIADWYEDD YCHWANEGOL 2020-21 Meini prawf ar gyfer dyrannu Grant

### Cyflwyniad

Mae tîm Gwasanaeth Gwybodaeth i Deuluoedd, Gofal Plant a Chwarae yn gwahodd ceisiadau am grantiau cynaliadwyedd ychwanegol i gefnogi sefydliadau gofal plant cofrestredig yn Sir Gaerfyrddin. Ni fydd swm y grant a roddir fel arfer yn uwch na £2000.

### Pwy all wneud cais?

Unrhyw grŵp neu unigolyn sydd wedi cofrestru gyda AGC sy'n gweithio gyda phlant 0-12 oed mewn trefniant gofal dydd o fewn Sir Gaerfyrddin. **Rhaid i bob ymgais gael ei gwblhau gan y Person/Unigolyn Cofrestredig.** Un cais a dderbynnir lle mae mwy nag un Gwarchodwr Plant yn cydweithio. **Rhoddir blaenoriaeth i leoliadau nad ydynt wedi derbyn unrhyw gyllid ers mis Ebrill 2020 neu sydd o dan pwysau ariannol cynyddol.** Byddwn yn ystyried lleoliadau sydd wedi profi cyfnod o gau o ganlyniad i ganllawiau Profi Olrhain a Diogelu (Rhaid eich fod wedi hysbysu Arolygiaeth Gofal Cymru a'r Gwasanaeth Gwybodaeth i Deuluoedd). Caiff ceisiadau eu hystyried a fyddai wedi derbyn arian grant arall o'r blaen yn y flwyddyn ariannol hon ac sydd o dan pwysau ariannol.

### Am beth allwch chi wneud cais?

Ymhlith eitemau gwariant mae costau staffio (ac nid wedi ei hariannu o dan y Cynllun Seibiant), rhent, gwresogi a goleuo, gofynion hanfodol o ran iechyd a diogelwch (profion blynyddol Profwr Dyfeisiau Cludadwy (PAT), Larwm Tân, Boeler, prawf prif gyflenwad trydan, yswiriant, nwyddau PPE) o ran rhedeg darpariaeth rhwng cyfnod 2020-21. Rhaid i'r anfonebau/derbynebau dangos yn glir cyfeiriad y darparwr gofal plant. **Ni ellir ariannu eitemau gwariant ddwywaith felly ni ellir hawlio unrhyw gostau sydd wedi'u hariannu gan grant arall o dan y grant hwn.**

**Ni ellir ystyried ceisiadau a wneir ar gyfer offer a theganau.**

## ADDITIONAL SUSTAINABILITY GRANT APPLICATIONS 2020-21 Criteria for Allocation of Grant

### Introduction

The Family Information Service, Childcare and Play team invites applications for additional sustainability grants to support registered childcare settings within Carmarthenshire. Grants awarded will not usually exceed **£2000**.

### Who can apply?

A group or individual registered with CIW working with children aged 0-12 years in a day care setting within Carmarthenshire. Only one application can be accepted where more than one Childminder works together. **Submission of application must be completed by the Registered Person/Individual.**

**Priority will be given to settings who have not received any form of funding since April 2020 or are under increasing financial hardship.** We will consider settings who have experienced a period of closure as a result of Test Trace and Protect guidance (You must have notified Care Inspectorate Wales and Family Information Service). Applications will be considered from settings who would have received other grant funds previously in this financial year and who are under financial hardship.

**Parent & Toddler groups are not eligible for funding from this grant.**

### What can you apply for?

Appropriate expenditure items incurred such as staffing costs (not covered by Furlough Scheme), rent, heating and lighting, essential health and safety requirements (Annual PAT Tests, Annual Fire Alarm Tests, Boiler Service, Electricity Mains Test, Insurance, PPE) costs incurred in running a provision during the year 2020-21. Invoices/Receipts must clearly show the address of the Childcare Provider. **Expenditure items cannot be double funded therefore any costs which have been funded by another grant cannot be claimed under this grant.**

**Applications made for equipment and toys cannot be considered.**

### Closing Date

Closing date for online applications is **Sunday 7<sup>th</sup> February 2021**.

**Late applications/incomplete applications will not be considered.**

### Key dates:

- All applications must be completed online via the link: <https://fis.carmarthenshire.gov.wales/additional-sustainability-grant-for-childcare-providers/> by **Sunday 7<sup>th</sup> February 2021**.
- All funding must be spent by **31<sup>st</sup> March 2021** and completion of relevant documentation SG1 and SG2 with copy receipts/invoices must be returned.

**PLEASE NOTE: THE GRANT IS REPAYABLE IN FULL SHOULD THE CHILDCARE PROVISION CEASE WITHIN 12 MONTHS OF RECEIPT OF GRANT.**

A certain amount of budget is available for this grant. However, the number of application requests we receive always exceeds the funds available. Therefore, some good applications, while meeting our criteria, may have to be refused.
