

Dear Setting Manager/Stakeholder

As of September 2021 the duties placed on the Local Authority in relation to children with Additional Learning Needs will be changing. This change is reflected through a new legislative framework, the Additional Learning Needs and Educational Tribunal (Wales) Act 2018 and the ALN Code 2021 which provides statutory guidance for all.

The new legislative framework imposes requirements on local authorities and governing bodies of maintained schools and education institutions ("FEIs") in respect of specific functions under the Act. This ranges across 0 to 25 age groups and as such widens the duties imposed on the LA with regards to children with ALN of 0 – 5 years of age. The ALNET Act and ALN Code specifically sets out three overarching objectives which are:

1. a unified legislative framework that supports all children of compulsory school age or below with ALN, and young people with ALN in school or further education;
  2. an integrated, collaborative process of assessment, planning and monitoring which facilitates early, timely and effective interventions; and
  3. a fair transparent system for providing information and advice, and for resolving concerns and appeals.

Within the Inclusion Department we have been considering and planning for this change for some time. Over forthcoming weeks and during the 3-year transition period starting from September 2021 the early years sector will see significant remodeling and development. Extensive support and training will be given by the Inclusion Department to support these changes which in turn will improve services and provision for young children with ALN and their families. We are working in partnership with our colleagues in the Family Information, Childcare and Play Team (Children's Services), with whom you will already be familiar. Many of you already access mandatory training coordinated by Education and Children's Services.

You will be able to continue to access various grants (including sustainability grants) and support and advice regarding regulatory matters. We will continue to work collaboratively to ensure that your individual ALN training needs are identified, and that training is made available to you to address these needs at times which accommodate your services.

For a number of years settings such as yourselves have accessed additional financial support for children who present with additional needs through the Team Camau Bach Helping Hands referral processes. This mechanism of advice and support has been of great value to the early years sector.

In line with the changes set out above it has been agreed that the current Helping Hands referral processes and access to support in relation to ALN will be transferred to the Inclusion Department as of the 1<sup>st</sup> April 2021. The system and referral process as it stands will not change immediately it will remain in its current form during the Summer Term 2021. This term will act as a period of development while we consider the processes we require going forward into the new system.

## Annwyl Reolwr Lleoliad/Rhanddeiliad

Ym mis Medi 2021 bydd y dyletswyddau a osodir ar yr Awdurdod Lleol mewn perthynas â phlant ag Anghenion Dysgu Ychwanegol (ADY) yn newid. Adlewyrchir y newid hwn drwy fframwaith deddfwriaethol newydd, sef Deddf Anghenion Dysgu Ychwanegol a Thribiwnlys Addysg (Cymru) 2018 a Chôd Anghenion Dysgu Ychwanegol 2021 sy'n darparu canllawiau statudol i bawb.

Mae'r fframwaith deddfwriaethol newydd yn gosod gofynion ar awdurdodau lleol a chyrff llywodraethu ysgolion a gynhelir a sefydliadau addysg ("Sefydliadau Addysg Bellach") mewn perthynas â swyddogaethau penodol o dan y Ddeddf. Mae hyn yn amrywio ar draws grwpiau oedran 0 i 25 oed ac felly mae'n ehangu'r dyletswyddau a osodir ar yr Awdurdod Lleol o ran plant ag Anghenion Dysgu Ychwanegol rhwng 0 a 5 mlwydd oed. Mae Deddf Anghenion Dysgu Ychwanegol a Thribiwnlys Addysg Cymru (2018) a'r Côd ADY yn nodi'n benodol dri amcan cyffredinol sef:

1. fframwaith deddfwriaethol unedig sy'n cefnogi pob plentyn o oedran ysgol gorfodol neu iau sydd ag ADY a phobl ifanc ag ADY mewn ysgolion neu addysg bellach;
  2. proses integredig, gydweithredol o asesu, cynllunio a monitro, sy'n hwyluso ymyriadau cynnar, amserol ac effeithiol; a
  3. system deg a thryloyw ar gyfer darparu gwybodaeth a chyngor, ac ar gyfer datrys pryderon ac apeliadau.
