Mae hyn yn cynnwys gwarchodwyr plant, darparwyr sector preifat a gwirfoddol, a lleoliadau a gynhelir sy'n cynnig gofal dydd, gofal cofleidiol neu cynlluniau chwarae yn ystod y gwyliau. Gellir hefyd ystyried ceisiadau gan ddarparwyr gofal plant sydd yn y broses o wneud cais i gofrestru. Bydd angen (i'r Cyngor) fod yn fodlon bod y darparwr yn y broses o wneud y cais hwnnw i AGC. Rhaid bod y darparwr gofal plant wedi'i leoli o fewn Sir Gâr.</p> <p>Ni all darparwr wneud cais i fwy nag un Awdurdod Lleol er y gall fod yn cymryd plant o fwy nag un Awdurdod.</p> <p>Wrth wneud cais rhaid i'r ddarparwr:</p> <ul style="list-style-type: none"> - Allu dangos bod galw heb ei ddiwallu am ofal plant; - Cofrestru gydag AGC neu yn achos darparwyr newydd, rhoi addewid ysgrifenedig y bydd yn cofrestru gydag AGC cyn gynted â phosibl. Os nad yw lleoliad wedi cofrestru o fewn 6 mis ar ôl tynnu'r grant i lawr yna gall y Cyngor gymryd camau i adfer yr arian; - Cofrestru gyda Cyngor Sir Ceredigion i ddarparu'r lleoedd Cynnig Gofal Plant neu roi addewid ysgrifenedig y bydd yn cofrestru gyda'r Cyngor; - Gallu dangos sicrwydd deiliadaeth am o leiaf 5 mlynedd. Lle bo llai na 5 mlynedd ar ôl ar y prydles, gellir ystyried ceisiadau lle gall y darparwr ddangos bod ymrwymiad neu fwriad clir gan y landlord i adnewyddu'r les; 	<p>All settings registered with Care Inspectorate Wales (CIW) who are offering Childcare Offer places for 3 and 4 year olds or who intend to offer places are eligible to apply. This includes childminders, private and voluntary sector providers, and maintained settings offering day care, wrap around care or holiday play schemes. Applications can also be considered from childcare providers who are in the process of applying for registration. (The Council) will need to be satisfied that the provider is genuinely in the process of making an application to CIW. The childcare setting location must be based in Carmarthenshire.</p> <p>A provider cannot apply to more than one Local Authority even though they may be taking children from more than one Authority area.</p> <p>In making an application a provider must:</p> <ul style="list-style-type: none"> - Be able to demonstrate that there is an un-met demand for childcare; - Be registered with CIW or in the case of new providers, give a written undertaking that it will register with CIW at the earliest opportunity. If a setting is not registered within 6 months of grant having been drawn down then the Council may take steps to recover the funds; - Be registered with Ceredigion Council to deliver Childcare Offer places or give a written undertaking that it will be registering with the Council; - Be able to demonstrate security of tenure for a minimum of 5 years. Where the number of years remaining of a lease is less than 5 years, consideration may be given to applications where the provider is able to show that there is a clear

You will need to submit 3 estimates, and a clear rationale for choosing your option to accompany the application. - In accepting this offer of funding the applicant agrees to provide Childcare Offer places for a minimum of 5 years from the date the grant funding is paid; - If the applicant fails to accept children being funded via the Offer, then it will be liable to repay all or part of the funding. This will not apply if the applicant can clearly demonstrate that he / she would welcome children under the Offer but there is no take up; - If the setting stops providing Childcare Offer places or routinely accepts fee paying children over those in receipt of the Offer, then they will be required to re-pay all or part of the grant funding paid; - The funding must be spent solely on those items deemed eligible for funding, if there is evidence that any part of the funding has been used for ineligible items then the setting will be required to repay that amount; - A provider may apply for funding for the same setting more than once in any financial year, provided that the total
